1. Call to order:

The Chairman called the meeting to order at 1702 hours EDT (Eastern Daylight Time).

2. Opening Remarks from the Chair: Due to the COVID 19 crisis and the restrictions on travel is was decided to hold a virtual Annual Board of Trustee meeting for the HGMF. In addition, there were a number of observations by the Ways Team with respect to our submission ref the HGMF and possible amalgamation with the PPCLI Foundation that we need to address.

The approval of agenda was moved by Jim Croll, seconded by Stephen Bartlett. Carried

4. Approval of Minutes of the HGMF BoT Meeting, of 7 August 2019:

Motion to approve minutes was moved by Dougal Salmon, seconded by Jim Croll. Carried

5. Observations by Ways Team ref HGMF (as per attached slides)

As per the slide the HGMF is not clearly separate from the PPCLI Association. We have fallen into the habit of conducting HGMF business during PPCLI Association meeting. For example, funds for Cadets from the HGMF must be approved by the HGMF BoT.

We have renamed student bursaries to HGMF Educational Bursaries. The PPCLI Association receives and reviews Bursary applications on behalf of the HGMF. However, the HGMF will approve the actual number and amount of educational bursaries

Don Dalzeil is working on HGMF By-laws. Dougal and Paul are working on a HGMF BoT Handbook. Handbook will be concise. Biggest issue will be adding fundraising as a responsibility of VP West. Once completed it will be passed secretarially for comment and final review.

Paul will work with Robert Curtin to develop an HGMF logo. We will immediately cease using the PPCLI Association logo on HGMF documents.

6. Financial Committee update 2019 - Finance Committee Chair: (as per attached slides)

Dave reported that the HGMF made 14% in 2019. The disbursement quota for 2020 is \$29,266. The HGMF got off to a rocky start in 2020 due to COVID 19. However, by 6 May 2020 the fund was recovered very well. The net decrease is \$22,930 or 2.7%. Marv Fenrich has been doing an outstanding job of managing our funds.

7. HGMF Financial Position and Statement of Income 31 Dec 19 and 30 Apr 20 (as per attached slides)

Jim reviewed HGMF Financial Position and Income Statements as of 31 Dec 2019. Due to COVID 19, the Auditor has not started the audit yet. It will most likely be completed in the fall.

Jim also reviewed HGMF Financial Position and Income Statements as of 30 Apr 2020.

There was a short discussion on actual funds disbursed. In 2019 the following funds were disbursed from HGMF.

Student Bursaries	\$21,000
Cadets	\$ 4,500
Mental Health	\$14,800
Soldier On	\$ 1,500
Total	\$41,800

The funds expended for Mental Health are on the travel line in the HGMF Statement of Income. In future we need to report Mental Health / Peer Support as a separate line in the budget. Jim explained the challenges of using simply accounting as our software program.

8. HGMF Fundraising 2018 – 2020 (as per attached slides)

Paul reviewed fundraising results for 2018 – 2020. In 2019, we exceeded our fundraising goals in 2019 due to the requests submitted to True Patriot Love, (\$7,000) General Dynamics (\$5,000), and Cubic (\$2,500) for support of Peer Support workshops. Paul to confirm what will happen with TPL grant due to COVID 19 restrictions. Pete Leger and Paul are looking at what can be accomplished via virtual workshops

9. 2020 HGMF Support to Cadets (as per attached slides)

Dougal reviewed the Cadet Corps requests for funding in support of Cadet Corps.

Moved by Dougal Salmon, seconded by Jim Croll that the PPCLI Cadet Corps listed below be allocated the funds indicated for 2020.

- 533 Winnipeg \$1,000
- 2943 Campbell River Suggest \$2,000
- 2483 Esquimalt \$1,000 plus \$1,000 as 2020 Top Cadet Corps

Dave explained that once the Annual HGMF Budget is approved, we should be able easily approve donations based on the approved budget.

10. Approval of 2021 HGMF Budget (as per attached slides)

The Proposed 2021 Budget was reviewed. The intent is to only cash in \$25,000 of investments from 2019. In 2019, we had a net increase of \$104,126 in investments.

Requested that Travel expenses be changed to read Trustees vice Directors. Done.

Currently we have a small credit with Commonwealth Memorial War Graves commission. Have not received projected costs for 2021.

It was confirmed that we are not responsible for maintenance of Hamilton Gault Statue near the National War Memorial. However, the Ottawa Branch conducts overwatch to ensure that it is maintained.

Maintenance Agreement vice Lansdowne Park has not been signed yet. There is a small crack on the top of the memorial . Cost of repairs should be around \$1,000.

Jim Croll moved the 2021 HGMF budget be approved. Seconded by Dave Pentney.

11. Status of additional HGMF Charitable Objects (as per attached slides)

The Trustees reviewed the status of request to update HGMF Charitable objects. On 5 September 2019 CRA asked for additional information. We have not had time to respond. Given the possible amalgamation with the Foundation. Should we proceed. Don Dalziel briefed on John Logan's comments to the Ways Team ref CRA in that it raises our profile and will result in extra scrutiny. Dave Pentney briefed on the Ways Team progress to date and the time required to consider the challenges of amalgamating two differ funds. Are the proposed charitable object critical and if we stand down what impact will this have on current charitable objects. After discussion it was agreed by all that we do not pursue the proposed charitable objects. Paul is to send a letter to CRA explaining that we will not pursue updating HGMF charitable objects at this time.

12. HGMF Logo (as per attached slides)

Paul reviewed that we have fallen into the habit of using the PPCLI Association logo on HGMF documents. This is wrong and gives an impression the HGMF is linked to the PPCLI Association. Paul will work with Robert Curtin to develop an HGMF logo. Once designs have been created they will be passed to the BoT for comment and approval. We respect Regimental Intellectual Property rules.

13. Addition of St Bartholomew's East Memorial Stained-Glass Window as a Regimental Memorial (as per attached slides)

Don Dalziel briefed on the history on the East Memorial Or Ottawa Window at St Bartholomew's Church in Ottawa. The window was installed by the Duke Of Connaught, Princess Patricia's father and Governor General.

Moved by Paul Hale that the East Memorial Window in St Bartholomew's Church be recognized as a Regimental Memorial. Seconded by Dougal Salmon.

#### Carried

After discussion it was confirmed that the window is listed in the Regimental Monuments and Memorials Manual. Ottawa Branch was approached by St Bartholomew's Church to raise 10% or \$20,000 towards the restoration of the window. No commitment has been made and they already have indications of \$10,000 in donations. The HGMF will be able to issue charitable tax receipts for donations made in respect to this project, since it is in the memorial manual and is a significant Regimental Memorial.



The St Bart's East Memorial Window on the west wall of the church.



Detail of the lower left pane. The Wounded Warrior, Lt Col Farquahar, is being escorted to the presence of the Warrior Saints by St Raphael and St Gabriel.

#### 13. St Bartholomew's East Memorial Stained Glass Window



The large descriptive plaque mounted on the north wall at the front of the Chapel. It lists ten names, the members of Prince Arthur's Rideau Hall staff who were killed during WWI. Three were Patricia's: LtCol Farquhar, the first CO, who died of wounds at St Eloi on 20 Mar 1915; Capt Buller, the first Adjutant and second CO, killed at Mount Sorrel on 2 Jun 1916; and Capt Newton, the first Patricia officer to be killed in action, at Vierstraat, Belgium on 8 Jan 1915. 16
